

Humanitarian project of the institution "Center for Social Services of the population of the Central district of Gomel"



1. Name of the project: "THE WORLD IN WHICH I LIVE - WITHOUT BORDERS"

2. Project implementation period: 24 months

3. The applicant organization proposing the project: the institution "Center for Social Services of the population of the Central district of Gomel" (hereinafter-the Center)

4. Project objectives:

to create conditions for the integration of people with disabilities and with special features of psychophysical development through innovative means and accessible infrastructure elements into public life, protection from discrimination;

strengthening the material and technical base of the center to improve the

availability and quality of social services;
creation of an organized "therapeutic" environment for stress relief,
development of sensory feelings in people with special psychophysical
development, people who have experienced psychological trauma.

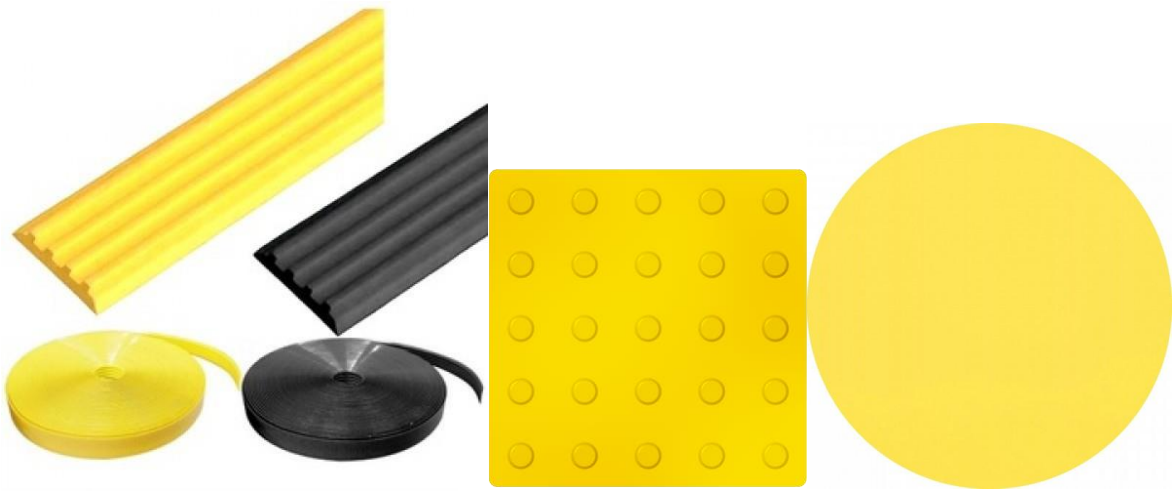
5. Tasks planned for implementation within the framework of the project:
to equip the department of rehabilitation, habilitation of disabled people with
technological equipment of an accessible environment for citizens with
musculoskeletal system, vision and hearing disorders;
equip the activation sensor room with all the necessary projection and
interactive equipment, lighting and music equipment, touch panels, mirrors,
etc.
to adapt disabled people in modern society by solving the tasks of arranging
an accessible environment at the place of residence;
to carry out various activities using technical means to attract the target group
to the created infrastructure;
to promote the harmonization of the mental and physiological state of
people with disabilities.

6. Target group:
disabled people of groups 1, 2 and families raising children with disabilities,
people who have experienced psychological trauma, living in the Central
District.
5906 persons with disabilities live in the Central district, including:
193 – visually impaired (1gr.-62, 2gr.-31, 3gr.-77);
230- hearing impaired;
318 – wheelchair users;
537 –disabled children.

7. Brief description of the project activities:

Preparatory stage I includes:
Monitoring of the available environment of the target group of the project,
development of design and estimate documentation (completion period is 1st-
2nd months of the project).

The MAIN stage II includes:1) The acquisition and installation of elements of
an accessible environment, speech informants, special electroacoustic
equipment for people with hearing impairment to ensure safe and free
movement without assistance in the department (3rd-4th months of the
project);





2) purchase of a special vehicle with a lift for transporting citizens with disabilities (5th-7th months of the project);



3) purchase of equipment for the creation of a sensory room equipped with the most necessary elements for the development of sensory senses, the removal of psycho-emotional tension (soft modules, dry pool with balls, sensory and tactile paths, suspended swing, tactile panels, dry shower), fiber optic and light products, products based on fiber "Cascade-100", a bundle of fiberoptic fiber, interactive sandbox and much more (8th-12th months of the project).



4) formation of a call center on the issue of creating an accessible environment for the disabled at the place of residence (acceptance of applications, allocation of financial assistance for the purchase, installation of equipment at the expense of the project) (13th-20th month of the project).

The FINAL stage III includes:

1) carrying out rehabilitation, habilitation measures for the disabled within the framework of the project (publications, speeches);

- 2) conducting training seminars for specialists demonstrating the positive experience of integrating the target group of the project into public life;
- 3) organization of master classes on the use of innovative technologies (22nd-24th months of the project).

Expected result:

- 1) The Department of Social Rehabilitation, habilitation of disabled people of the Center will be available to people with disabilities;
- 2) More than 3 thousand disabled people will be able to use the services of the sensory room free of charge.

Classes in the sensory room will contribute to:

relieving muscle and psycho-emotional tension, achieving a state of relaxation and mental balance;

activation of various functions of the central nervous system by creating an enriched multisensory environment;

stimulation of impaired sensory functions (vision, touch, hearing, etc.);

development of motor functions.

3) Thanks to this project, more than 24 events aimed at the adaptation of disabled people in modern society will be held;

4) More than 5 thousand citizens will be able to receive rehabilitation and habilitation services in a timely and high-quality manner, including the delivery of wheelchair users in a special car with a lifting device to the Center to participate in the work of interest groups and clubs;

1) 5) An accessible environment will be created at the place of residence for more than 30 disabled people.
